Pursuant to Section 29-1-109, C.R.S., the Board of Green Gables Metropolitan District No. 2 (the "**District**"), hereby certifies that a regular meeting of the Board of Directors of the District, was held on November 8, 2023, via Microsoft Teams video / telephone conference.

A. At such meeting, the Board of Directors of the District adopted that certain Resolution No. 2023-11-04 to Adopt Budget appropriating funds for the fiscal year 2024 as follows:

General Fund \$ 135,000 Debt Service Fund \$1,012,000 Capital Projects Fund \$ -0-

- B. The necessity has arisen for additional Capital Projects Fund appropriations requiring the expenditure of funds in excess of those appropriated for the fiscal year 2024.
- C. The source and amount of revenues for such expenditures, the purposes for which such revenues are being appropriated, and the fund(s) which shall make such supplemental expenditures are described on **Exhibit A**, attached hereto and incorporated herein by this reference.

NOW, THEREFORE, BE IT RESOLVED that the Board of Directors of the Green Gables Metropolitan District No. 2 shall and hereby does amend the budget for the fiscal year 2024 as follows:

Capital Projects Fund \$ 250,000

BE IT FURTHER RESOLVED, that such sums are hereby appropriated from unexpected revenues available to the District to the Capital Projects Fund for the purposes stated.
